### NJYHL OFFICER REPORTS

---

#### President Report

---

- AAHA Annual Meeting – June 2016
  - Maureen elected Secretary succeeding Linda Ryan and awarded New Leader award
  - Charlie Heger was awarded the Volunteer of the Year
- All organizations that may have AA teams that are eligible for nationals (14U, 16U, 18U) must complete an application for approval to be qualified to be in contention for the national tournament in the 2017-2018 season. These forms are due on November 30<sup>th</sup> 2016 for the 2017-2018 season. This form and instructions will be released shortly.

- New tryout dates were passed at the AAHA Annual meeting. Tryouts are now officially on two different schedules – 8U, 10U and 12U are scheduled for Monday 4/3/17. 14U, 16U and 18U are scheduled for Monday, April 17<sup>th</sup>. These changes were made to align with USA Hockey national rule regarding tryouts. Non-national bound Tier I teams can start tryouts 48 hours after the end of their District tournament (with Tier II following the next week). The older players remain at 48 hours after the end of the National Tournament.
- Lori is a grandmother a second time, Al is a first time grandfather. Kevin Angert has a new grandson too.

### Commissioner Report

---

- All organizations need to send the contact information of the person responsible for tracking USAH Rule 411 – progressive penalties to Bill Fox. He has received this information from 11 teams as of this meeting.
  - USA Hockey is now closely tracking these penalties.
  - Any organization that is not accurately tracking the penalties received by their players or coaches and ends up in violation of this USAH rule may lose playoff eligibility by permitting an ineligible player on the ice. Please make it your point to keep track.
  - Bill Fox will circulate a sample form electronically to help organizations keep track of this issue.
  - **It is the individual organization's responsibility to track these penalties. All USAH major penalties (non-league) are included. USAH is now monitoring all of this.**
- Please send any feedback on the managers meeting so we can improve the format.

### Executive Vice President Report

---

- Current NJYHL Guidebook online is for 2016-2017 season.
  - Rule changes are highlighted.
  - There is a separate list of fines.
- Managers meeting was on 8/30/16. Very well attended. NJ Devils, Glenn Hefferan (AAHA President) and Gene Palecco (AYHL Commissioner) were there. Gene taught the attendees how to use the Score Keeper system.

---

### Administrative Vice President Report

---

- Squirt evaluations will be compiled and evaluated as soon as possible after the jamboree and then the divisions will be created.
- Attending the North Jamboree does not mean your team will play in the north. NJYHL must equitably balance out the divisions.
- Scorekeeper passwords for the squirt teams will be shared after the jamboree.
- Playoff formats will be similar to last year. They will be posted shortly.
- Reminder that the number of teams that advance to Districts is set by the AAHA.
- Tiebreaker rules were updated this year and are in the Guidebook.

- Please note that the Score Keeper system does not recognize the league tiebreakers. If there are two teams tied, the system defaults to alphabetic. Please share this with your coaches, managers and families.
- Scoresheets were distributed this evening. There should be more than enough for the entire season and then some.
- Please remind your families that game statistics will only be corrected if it impacts the final outcome of the game. Goalie shots, assists, etc. will not be corrected.
- We recommend that you remind your score keepers that game statistics are easiest when they are entered as if you are scoring the game live.
- It is the home team's responsibility to have competent persons keeping score during the game.
- Know the difference between a Misconduct and Game Misconduct
- Coaches should be carefully checking the score sheet before signing at the end of the game.
- Please remind your families that only the DELEGATE (or MASTER SCHEDULER for scheduling issues) should be communicating with the NJYHL. All communication should be filtered through these two positions.
- Please remind your families that Officials do not assess suspensions. They assess penalties. Suspensions are managed by written rule and by the NJYHL Commissioner.
- Only the NJYHL can declare forfeits – team coaches and managers cannot decide to forfeit a game.
- Season dates:

  - Midget A, Bantam, Pee Wee – September 10<sup>th</sup> – February 12<sup>th</sup>
  - Squirts – October 8<sup>th</sup> – February 12<sup>th</sup>

    - October 1-2 - Ice Vault (NJ teams)
  - Midget AA playoffs - October 28-30<sup>th</sup> – Ice Vault
  - AAHA Midget AA Districts (best of 3) – week of 10/31 (participating teams host) – winners advance to Nationals
  - Squirt and Pee Wee playoffs – February 24-26 – Aspen Ice
  - Bantam and Midget A playoffs – March 10-12 – Igloo
