Introductions

- Frank McGady, NJYHL President, introduced the NJYHL board to all members in attendance. HE also introduced the AAHA President and Andy Gojdycz, NJ Devils representative.
- Frank thanked all for attending and for their support of the NJYHL.

Secretary's Statement

- Maureen Thompson-Siegel, NJYHL Secretary, described the contents of the meeting booklet, which included the following:

- All documents, including the Treasurer's report, will not be ratified at this meeting as the voting members are defined as the club delegate in the NJYHL rules. The above referenced documentation is distributed for information only.
- If there are any updates to contact information for the President, Delegate, Coaching Director, Master Scheduler, please feel free to send them to the Secretary for updating.

• If there are any human interest stories for our website, please submit these to Lori Tomasello, as she is responsible for the website.

AAHA President's Report

- Glenn Hefferan, AAHA President, welcomed all to the meeting and thanked all member organizations for their support of USA Hockey, the Atlantic District and the growth of youth hockey in the state of New Jersey.
- Glenn described some new initiatives currently underway in the AAHA, including:
 - Development and growth of girls hockey. Glenn challenged the member clubs to grow the sport. Even increasing by ten girls per organization will be a large impact overall.
 - Glenn also challenged the organizations to increase the diversity of our sport.
 Reach out to under-represented groups to encourage them to try the sport.
 - o Glenn congratulated the USAH Junior team on their gold medal win vs Canada in the World Junior tournament.
 - O Glenn let the membership know that the AAHA Tiering review committees are hard at work reviewing applications. Results should be announced shortly. All existing Tier II, NJYHL members are summarily approved, but Glenn requests that each organization begin to seriously consider competition levels when declaring teams. It does not benefit the development of the players if they are playing at a level not appropriate for the team's skill.
 - This is a USA Hockey Rule Change year. There are 212 pages of proposed rule changes. Highlights include:
 - Change of all minor penalties to 1:30 from 2:00
 - Removal of body checking from the bantam level
 - Removal of the waiver of icing on the short-handed team
 - Faceoffs at the nine dots
 - Clarification for helmet removal match penalty
 - Discussions on ADM and the potential for a waiver from USA Hockey to permit an amount of full ice games for pure 8 year olds in the District. The proposal for a waiver must be approved by the USA Hockey committee at the winter meetings.
 - The NHL will be unveiling a new initiative for a culture change within the sport.
 This will try to address the "race to nowhere" and to bring realistic expectations to the progression in youth hockey.

New Jersey Devils

- Andy Gojdycz presented a renewal promotion called the squirt shoot out. He asked each member organization submit the name of a squirt aged player and goalie that will compete to be the best in the state. The competition will be on January 18th. The winners will be sent to the NHL All Star Game to compete in a national competition.
- NJ Devils in cooperation with USA Hockey offer free ADM clinics to different player populations. There will be a goaltending clinic on 2/10 and a Tier II clinic on 2/25.
- Clinics can be offered at your home rink as well. Contact Maureen Thompson-Siegel to schedule.

Treasurer's Report

- Charlie McLaughlin, NJYHL Treasurer reviewed the current Treasurer's report with the attendees. The report will be ratified at the next Delegate's meeting in February.
- The overall operating budget is lean and the organization has operated in this manner for several years. However, as with all things, it may be necessary to increase team fees by a small amount either next year or the following year to keep up with the inflation of expenses (ice costs, etc.).
- Each organization also pays annual membership fees and these fees are the cornerstone for our income. The due dates for these fees are listed in our Guidebook.
- NJYHL is a 501(c) 3 non-profit organization. The IRS 990 is a public document and available for inspection.
- We also collect fines for various rule infractions from absences at meetings to incorrect score sheet completions. These fines contribute to the overall operating budget. The fine amounts are listed in the NJYHL Guidebook.
- The NJYHL is currently operating at a profit. Income is also provided by apparel sales at the playoffs and from fines assessed for infractions as listed in our Guidebook.
- The AAHA Financial Obligation list is published annually to assist organizations with their collections. Player families that have outstanding obligations to their existing organizations can be added to this list with the purpose of preventing them from being rostered with a new team before their financial obligation is met to their existing organization.
- Charlie reminded all that any club with an outstanding balance is prohibited from voting at the Annual meeting in April.

Executive Vice President's Report

- Gene Ross, NJYHL Executive Vice President, reviewed the annual due dates for the following:
 - Rule changes are due before the March 14th Delegate's meeting. They are compiled, distributed for review and comment, and voted on at the April 11th Annual meeting. Rule changes are to be submitted directly to Gene.
 - O Applications from new organizations requesting to join the NJYHL are due by 30 days prior to the February Delegate's meeting. As of this meeting applications were received from the Union Thunder, Jersey Wolves and Nassau Hockey. Information on these clubs will be sent to the Delegates for review shortly. The prospective members will present and be interviewed at the March Delegates meeting. The Delegates will vote on their admittance to the NJYHL at that meeting as well.
 - Notice of venue changes, name changes and uniform changes are to be submitted at or before the February Delegate's meeting. They are voted on at the March Delegate's meeting.
- Gene reminded the attendees that there is a rule in the Guidebook that states that each
 member organization must have a competent voting member attend the Annual
 meeting in April. There is a \$200 fine for missing this meeting. The voting person at
 that meeting will be the Delegate unless Gene is notified in writing prior to the meeting
 of the name of the substitute.

• An online Organizational Profile will be required to be submitted after tryouts in the spring. There is a sample questionnaire in the meeting handout for your information.

Administrative Vice President's Report

- Lori Tomasello, NJYHL Administrative Vice President, reviewed how venues are selected for NJYHL events. Bid packages are released in May to all member organizations to share with their rinks. Bids are sent into the league, they are evaluated and locations are selected. The locations and dates for playoffs, etc. are posted after the Annual Meeting of the AAHA (typically held at the end of June).
- Playoff advancements are posted on the NJYHL website in September.
- The number of teams that advance to Districts are determined by the AAHA. The NJYHL
 does not have control over the number of teams participating.
- The National Tournament-bound Midgets (AA level) play a short season to accommodate the NJ HS schedule. It was voted on and ratified by the NJYHL membership several years ago. In order to play a full complement of games (approximately 20) the season must begin in mid-August. There was some discussion about lessening the number of games so that the teams can start about September 1st but it was pointed out that all players must meet the 20/10 rule for game participation in order to be eligible to participate in Districts/Nationals. Fewer games can put players in jeopardy of not complying with this rule.
- Lori reviewed that it is the organization's responsibility to insure that all score keepers are competent and understand the rules of the game. There are over 400 teams in the NJYHL and there are too many mistakes made score keeping where penalties are concerned. It is incumbent on the home team to keep an accurate record of the game and to enter that record into the electronic scorekeeping system in a timely manner. All games are required to be entered within 24 hours of the end of the game or before the next NJYHL game for both teams, whichever comes first. Fines are assessed for all games not entered into the electronic system by Tuesday at 12 noon for all games played the previous weekend. Fines are also assessed for all corrections that must be made.
 - The Lawrence Flames suggested that a minor programming change may handle most of the issues with the misconduct/game misconduct mistakes. They suggested that an "are you sure you want to submit a Game Misconduct" with a short definition listed may mitigate many problems when Game Misconduct is selected. Lori stated the NJYHL does not control the programming but she will investigate if this change can be implemented.
- Inclement weather cancellations are difficult to manage as the weather in one part of
 the state may differ from another part of the state. We expect teams to use their best
 judgment but please note that only the Master Scheduler from each organization can
 cancels and reschedule a league game. The Guidebook states that all weather related
 cancellations must be rescheduled within seven calendar days.
- All scheduling communications are sent by Lori to the Master Schedulers of each organization.
- Lori re-emphasized that any scheduling or scorekeeping issues that need to be communicated to the NJYHL be managed by one person from each organization. It is

too difficult to respond to varied members from each organization. Please insure that one person is designated for your organization.

Registrar and Risk Manager's Report

- Al Di Mauro, NJYHL Registrar and Risk Manager, asked Frank McGady to report that all
 rosters are frozen on December 31st. Goaltenders are exempt from this rule but
 goaltending coverage must be approved by both the Registrar and the Commissioner.
- All serious injures should be reported to Al DiMauro when they occur. We are fortunate that we have not had any serious injuries so far this season.

Coach in Chief's Report

- Tony D'Anna, NJYHL Coach in Chief, hosted Coaching director meetings in August. These
 meetings reviewed the rules and requirements for the NJYHL. It was expected that each
 organization coaching director shared the information learned with their respective
 coaching staff.
- Tony thanked all evaluators for participating in the Squirt jamboree. The inclusion of many coaching directors in the evaluation process helps insure that all teams receive a proper placement.
- As it is now after 12/31, all coaches currently on the rosters should have the following proper credentials:
 - Safe Sport Certification (good for two seasons)
 - Background screening (good for two years unless the coach switched organizations)
 - o Age-specific online module
 - Current CEP clinic certification
- Tony circulated a USA Hockey report that captures every rostered coach in our league and the status of their credentials.
 - All coaches that did not update their CEP by 12/31 must be permanently removed from the bench (roster) for the rest of the season. They will also be ineligible to coach next season in accordance with our rules until they are approved by the NJYHL. A list of these coaches will be circulated to all clubs in February.
 - All coaches that have an up to date CEP but did not complete their on-line age specific module have until January 31st to complete them. They must be temporarily removed from the bench (roster) until such time that they complete this requirement. If they are not updated and completed by January 31st, they are considered ineligible to coach next season in accordance with our rules until they are approved by the NJYHL. These coaches will be included in the list circulated in February.

Referee in Chief's Report

• Frank McGady presented for the Referee in Chief. He stated that any questions that arise can be directed to the Referee in Chief.

 Maureen Thompson-Siegel presented for the Professional Liaison that all events are available by clicking on and joining the list serv available through the NHL link on the NJYHL website.

Commissioner's Report

- Player movements are frozen now that the rosters are frozen. Emergency goaltending coverage is permitted but must be approved by the Commissioner.
- Bill Fox thanked both Don Nichols and Tony D'Anna for their assistance in the review of major penalties and suspensions. Their assistance in this area has made the work more expedient.
- It is the organization's responsibility to be aware when a player or coach on their rosters has received a progressive penalty that can mean an assessment of a suspension.
 - Bill reminded the meeting that he receives automated notices from USA Hockey when game misconducts are received.
 - Players that participate on HS teams that play under USA Hockey rules, or that play on spring/summer teams are at risk of receiving penalties that may carry over into the NJYHL season.
 - Any player that participates in a game without serving a suspension will be subject to further discipline. The coach will also be suspended for playing an ineligible player and the organization will be fined \$1,000.
- Bill Fox stated it is a requirement that all players assessed a game misconduct at the end
 of this season are required to serve the suspension at the start of the next season.
 Please make sure that all players, coaches, managers within your organization are aware
 of this requirement. Any player that does not serve the suspension jeopardizes the
 coach and the organization who can unwittingly play an ineligible player.
- Spectator behavior is becoming increasingly more problematic. It is incumbent on each
 organization to properly communicate with their families to change the mindset and to
 remind all those watching the games that the players are children and it is inappropriate
 to behave poorly and unsportsmanlike in the stands. The NJYHL may be forced to
 reinstitute the rule wherein the player will be suspended if the parent is ejected from
 the game if game spectator behavior does not improve.

President's Report

- Frank congratulated the Jersey Penguins 16AA and the Brick Hockey Club 18AA on their advancement to USA Hockey Nationals. Penguins will be headed to Frisco, TX and Brick to Lansing, MI.
- All organizations that submitted for approval for AA status at the National Bound levels (14U, 16U and 18U) have been approved by the AAHA.
- The NJYHL Board of Directors positions that are up for election at the April Annual meeting are the President, Registrar and Secretary.
- Tryout dates for the 2017-2018 season are:
 - o 8U, 10U, 12U start on April 3, 2017
 - o 14U, 16U, 18U start on April 17, 2017

• Frank thanked Ryan Gibbons for his service to the NJYHL. Ryan resigned as Executive Vice President in September. Frank welcomed Gene Ross to the position and wished him well with the new position.

- Frank McGady, NJYHL President, began the introductions of all members in attendance. All organization members, NJYHL Board Members, AAHA President and AAHA Registrar were introduced.
- Frank thanked all for attending and for their support of the NJYHL.
- Frank also wanted to announce that Kevin Dineen, Toms River Blackhawks President stepped down and is being replaced by Diano Tarrabachia. The NJYHL thanks Kevin for his service and support and wishes him well. The NJYHL also wished Diano good luck in his new position.
- Frank also announced that Lou Galli, NJYHL Master Scheduler and Webmaster has
 resigned from his position with the NJYHL. He thanked Lou for his dedication to the
 NJYHL and for "bringing the league into the 21st century". A replacement will be
 identified soon.
- Frank congratulated the Skylands Kings 16AA and the Jaguars 18AA on their USA Hockey Nationals berth.

Secretary's Statement

 Maureen Thompson-Siegel, NJYHL Secretary, distributed a draft version of the November Delegate's meeting minutes to all attendees for their information. These minutes will be approved at the next Delegate's meeting. Also distributed were the Agenda for this meeting, the latest Treasurer's report and a sample of the Progressive Penalty spreadsheet. • If there are any updates to contact information for the President, Delegate, Coaching Director, Master Scheduler, please feel free to send them to the Secretary for updating.

AAHA President Report

- Glenn Hefferan, AAHA President, welcomed all to the meeting and thanked all member organizations for their support of USA Hockey, the Atlantic District and the growth of youth hockey in the state of New Jersey.
- Glenn was elected at the AAHA Annual meeting in June 2015.
- Glenn described some new initiatives currently underway in the AAHA, including:
 - o The design and implementation of a new website for the District.
 - The refining of several legislative proposals that will be brought forth at the USA Hockey Winter meetings in Orlando, Florida the weekend of January 15th.
 - The pilot of a new coaching development program within the District for those young, career-minded coaches looking to progress from coaching youth hockey to coaching at higher levels (i.e. prep school, college, etc.). The expectation is to have an initial cohort of about 30 coaches in the program. More information to be released shortly.
 - Discussions on ADM and the potential for a waiver from USA Hockey to permit 10 full ice games for pure 8 year olds in the District. The proposal for a waiver must be approved by the USA Hockey committee at the winter meetings.
 - The review of the applications for independent Tier 1 status for the 2016-2017 season. Organizations that have submitted include Hatfield Ice Dogs, Jaguars, Jersey Shore Wildcats, Jersey Shore Whalers, New Jersey Freeze, Lehigh Valley Phantoms, New Jersey Hitmen, Palmyra Black Knights, Red Bank Generals and Skylands Kings. Evaluations and notices will be sent to the listed organizations within the month.

AAHA Registrar Report

- Tony Montagna, AAHA Registrar, reviewed the issue of midget players being listed on both a youth roster and on a junior protective list. USA Hockey rules state that a player cannot be listed on both after December 31st. Upon his review, there were over 100 players that were still included on both types of rosters, most of which occurred with New Jersey teams.
- AYHL allows the movement between a youth (midget) roster and a junior protective list until 12/31.
- Tony further explained the concept of a dormant team (excerpt from USA Hockey Annual Guide distributed at the meeting). Dormant teams play short season – there is an exception in the Annual Guide – can be dual rostered until 3/1 but then must be moved from junior protective to youth. Tony was happy to report that the NJYHL representatives at the National Tournament at both the U16 and U18 level do not have anyone on the dual rostered list.

Treasurer's Report and Financial Status of the NJYHL

- Charlie McLaughlin, NJYHL Treasurer reviewed the current Treasurer's report with the attendees. The report will be ratified at the next Delegate's meeting in February.
- NJYHL is a 501(c) 3 non-profit organization. The membership pays fees to be a member as well as team fees for each team that participates in the league. There is also a fee for each team that participates in the Squirt jamboree. It is important that the fees are pain on time. The NJYHL may institute fines for those organizations that do not pay their fees on time. The fee schedule and due dates are listed in the NJYHL Guidebook
 - League fee is due on or before September Delegate's meeting
 - Team fees and Squirt Jamboree fees are due at the next scheduled meeting after team declarations are due (typically August).
- Our annual tax returns and financials are prepared by Sobel & Co.
- The NJYHL is currently operating at a profit. Income is provided by apparel sales at the playoffs and from fines assessed for infractions as listed in our Guidebook.

- Ryan Gibbons, NJYHL Executive Vice President, reviewed the annual due dates for the following:
 - Rule changes are due before the March 4th Delegate's meeting. They are compiled, distributed for review and comment, and voted on at the April 4th Annual meeting. Rule changes are to be submitted directly to Ryan.
 - Applications from new organizations requesting to join the NJYHL are due by 30 days prior to the February Delegate's meeting. As of this meeting none were received, so none will be reviewed at the February Delegate's meeting.
 - Notice of venue changes, name changes and uniform changes are to be submitted at or before the February Delegate's meeting. They are voted on at the March Delegate's meeting.
- Ryan reminded the attendees that there is a rule in the Guidebook that states that each
 member organization must have a competent voting member attend the Annual
 meeting in April. There is a \$200 fine for missing this meeting. The voting person at
 that meeting will be the Delegate unless Ryan is notified in writing prior to the meeting
 of the name of the substitute.
- Ryan also reminded all member organizations that anyone with an outstanding balance to the league (fines, fees, etc.) are not permitted to vote. Please confirm that any outstanding monies due the league are paid prior to the April meeting.
- Ryan also reminded all member organizations that any organization that misses 60% of the Delegate's meetings in a year is placed on probation and will not be permitted to vote at the Annual meeting (currently means missing 3 scheduled meetings – June, September, November, February, March, April)
- Ryan Gibbons will require that all members submit an online organizational profile in the spring. This information will capture basic information on each organization including incorporation type, home rink, board of directors names, etc. He will send out an email when the system is ready to accept the information.

Playoff Structure and Venues, Score Keeping and Score Sheets

• Lori Tomasello, NJYHL Administrative Vice President, reviewed how venues are selected for NJYHL events. Bid packages are released in May to all member organizations to

share with their rinks. Bids are sent into the league, they are evaluated and locations are selected. The locations and dates for playoffs, etc. are posted after the Annual Meeting of the AAHA (typically held at the end of June).

- Playoff advancements are posted on the NJYHL website in September.
- The number of teams that advance to Districts are determined by the AAHA. The NJYHL
 does not have control over the number of teams participating.
- The National Tournament-bound Midgets (AA level) play a short season to accommodate the NJ HS schedule. It was voted on and ratified by the NJYHL membership over 5 years ago. In order to play a full complement of games (approximately 20) the season must begin in mid-August. There was some discussion about lessening the number of games so that the teams can start about September 1st but it was pointed out that all players must meet the 20/10 rule for game participation in order to be eligible to participate in Districts/Nationals. Fewer games can put players in jeopardy of not complying with this rule.
- There was also discussion on whether Bantam AA teams should also play a short season as they are also National Tournament eligible. It was discussed realistically, not all bantams are HS aged (some are in 8th grade), and playing a short season does not benefit them.
- Lori also reviewed that some teams are placed in divisions that may not be ideal geographically, but are placed to insure a proper allocation of games for all teams in the divisions. The NJYHL does its best to accommodate team placements if a club prefers that two teams on the same level do not compete against one another, etc.
- Lori reviewed that it is the organization's responsibility to insure that all score keepers are competent and understand the rules of the game. There are over 400 teams in the NJYHL and there are too many mistakes made score keeping where penalties are concerned. It is incumbent on the home team to keep an accurate record of the game and to enter that record into the electronic scorekeeping system in a timely manner. All games are required to be entered within 24 hours of the end of the game or before the next NJYHL game for both teams, whichever comes first. Fines are assessed for all games not entered into the electronic system by Tuesday at 12 noon for all games played the previous weekend. Fines are also assessed for all corrections that must be made.
- Inclement weather cancellations are difficult to manage as the weather in one part of the state may differ from another part of the state. We expect teams to use their best judgment but please note that only the Master Scheduler from each organization can cancels and reschedule a league game. The Guidebook states that all weather related cancellations must be rescheduled within seven calendar days.
- All scheduling communications are sent by Lori to the Master Schedulers of each organization.
- Lori also expressed her deep gratitude to Lou Galli for his service to the NJYHL. He served as Master Scheduler for the league as well as webmaster and worked hand in hand with Lori.

Rosters, Player Eligibility and Risk Management

 Al Di Mauro, NJYHL Registrar and Risk Manager, asked that all roster moves are kept to a minimum during the course of the season. Each team has 8 moves that are permitted

- each season from the start of the season through December 31st. These moves are meant to cover a team in an emergency or to see if a player will be better suited on a higher (or lower) skilled team. These moves should not be to fill out benches. All rosters freeze at that point. Each time a player is moved, Al is to be notified.
- Bill Fox, NJYHL Commissioner, reviewed how goaltenders are exempt from the rule Al mentioned above, but it is the rule that a covering goaltender must be from the same skill level or lower. For example, an "A" level pee wee goalie cannot cover a "B" level pee wee goalie's net, but the "B" level goalie can cover the "A" level goalie's net. If a "B" level pee wee goalie's net needs a substitute goalie, it must come from the next younger level.
- Bill also reminded all organizations that the AAHA Financial Obligations rule states that
 anyone with an outstanding financial obligation as of February 1st should be added to
 the AAHA outstanding financial obligations list. Be advised that anyone added to that
 list is also required to be removed from the roster at that time and cannot rejoin the
 team until the financial obligation has been met.
- From a risk management perspective, we are fortunate that we have not had any serious injuries reported so far this season.

Coaching Credentials, Training and Certifications

- Tony D'Anna, NJYHL Coach in Chief, hosted Coaching director meetings in August. These meetings reviewed the rules and requirements for the NJYHL. It was expected that each organization coaching director shared the information learned with their respective coaching staff.
- Tony also announced that Joe Lanza has been added as the Assistant Coach in Chief for the Southern part of the state. Joe works with Tony to manage all coaching issues in the NJYHL.
- Tony thanked all evaluators for participating in the Squirt jamboree. The inclusion of many coaching directors in the evaluation process helps insure that all teams receive a proper placement.
- As it is now after 12/31, all coaches currently on the rosters should have the following proper credentials:
 - Safe Sport Certification (good for two seasons)
 - Background screening (good for two years unless the coach switched organizations)
 - o Age-specific online module
 - o Current CEP clinic certification
- Any coach missing the information above is not permitted to be on the bench/ice with the players for the balance of the season.

Coaching and Player Suspensions, Progressive Penalties

• Tony D'Anna and Bill Fox presented an excel spreadsheet tool to the membership as a means of tracking progressive penalties in accordance with USA Hockey rules. Its use is not mandatory, but rather meant as a tool. The electronic file will be circulated as an attachment to these minutes.

- It was explained that the organization that the player is rostered with when receiving his third major progressive penalty is responsible for that player serving the related suspension. This is difficult to track if the player also participates on a USA Hockey HS team. It is up to the player and his coach to be open about when these types of penalties are assessed.
- Bill Fox stated it is a requirement that all players assessed a game misconduct at the end
 of this season are required to serve the suspension at the start of the next season.
 Please make sure that all players, coaches, managers within your organization are aware
 of this requirement. Any player that does not serve the suspension jeopardizes the
 coach who can unwittingly play an ineligible player.
- An email was sent out to all organizations a few days before this meeting requesting that the organization registrar forward a copy of their CEP report to Tony and to highlight all those coaches that HAVE NOT completed their credentials by 12/31. This information is required to comply with the NJYHL rule 82 which states, "Any coach that did not meet the CEP requirements for the current season by 12/31 will be suspended for a minimum of 45 days and a maximum of one year starting at the beginning of the following season. That coach will not be permitted to return until all CEP requirements are met, with final approval from the League Commissioner and the Coach in Chief". The NJYHL will compile a list of coaches in this category and will circulate to all organizations before the start of tryouts. This list will also be shared with the AAHA Registrar.
- A request was made from the Woodbridge Wolfpack to have access to the Official's
 Incident Report whenever one is filed. They want the ability to be able to see what the
 official's representation of an event which required documentation. Bill Fox and Ryan
 Gibbon explained that an Official's Incident report is a matter of record and is not open
 to revision or interpretation. It is documentation for an event that is shared with the
 AAHA Vice President for Protests, Suspensions and Appeals and with the NJYHL
 Commissioner.

Promotions and Events

- The NJYHL has a partnership with the professional organizations in the area and maintains a database that notifies the population with there are events of interest.
 Please encourage your organization members to register for this list-serv by click on the NHL button on the website.
- Maureen Thompson-Siegel, ADM Coordinator for the AAHA, also offered to all
 organizations the opportunity to have ADM clinics and parent/coaching education
 classes run at your home facility. Any interest can be directed to her. Offers are
 available for skills clinics, goaltending clinics, parent education, coaching education,
 player education.
- The NJYHL website also captures any human interest stories that the organizations are interested in sharing. Please send in the news stories and we will be happy to add them to the NJYHL website.

Junior Teams, Tier 1 Teams and NJYHL Rules

 Ryan Gibbons informed the membership that NJYHL currently does not have a rule in our Guidebook to address the issue of players being dual rostered on a junior/NJYHL team, but the feeling is that there should be something added to the rule book to address this concern. The recent proliferation Tier 3 junior teams makes this a concern for the NJYHL. A rule will be drafted for review and possible ratification at the NJYHL Annual meeting on April that will bring clarity/control to this issue and its impact on the NJYHL.

- Ryan Gibbons also informed the membership that a rule in our book will need to be
 modified to address a player on a Tier 1 team moving down to play on a NJYHL team.
 When the rule was written, it only contemplated the AYHL. With the advent of
 independent Tier 1 teams over the last few years, we need to revise this rule to reflect
 the current situation in New Jersey.
- Ryan continued to state that we also have to clarify how our current Tier 1 rule impacts female players that are dual rostered on a boys and girls team.
- Ryan asked the membership to submit suggestions for re-writes of these rules.

NJYHL OFFICER REPORTS

President Report

- Ryan Gibbons resigned his position as Executive Vice President recently. The Executive board has appointed Gene Ross to fill the vacant position for the balance of the term.
 Frank thanked Ryan for his years of service to the NJYHL and to youth hockey in general.
- USA Hockey Hall of Fame Induction Ceremony is at the Philadelphia Marriott Downtown on November 30, 2016. The AAHA has asked each member league to contribute to the purchase of tables at the event. The NJYHL has agreed to contribute as requested.

Commissioner Report

- Report presented by Lori Tomasello in Bill Fox's absence.
 - Parental ejections are too high. This information goes to the AAHA. We are getting close to suspending the player when the parent is ejected. Please share this information with your team families and remind them to show restraint when watching games.
 - All parental ejections must be communicated with the Commissioner. He needs their name for the AAHA records. Information must be shared as soon as the ejection occurs.
 - All suspension reports are sent from AAHA automatically to Commissioner. They
 are forwarded to the offending organization as a courtesy. Each organization's
 Delegate has a responsibility to be aware of suspensions assessed and to
 communicate these items with the NJYHL and the offending player/coach.
 - All players/coaches that receive have a match penalty assessed are sent directly to the AAHA. The AAHA forwards back to the Commissioner for review and management. Our rules state it is the offending organization's responsibility to notify the Commissioner within 24 hours of the match penalty. It is incumbent on the NJYHL organization to follow the rule.
 - As a reminder, a full game consists of a minimum of two periods. The mercy rule does not apply until the end of the 2nd period (with standard stop time and length).
 - Coaches cannot refuse to continue to play or remove the team from the ice during a game. That game stoppage is a match penalty for the coach.
 - All Delegates are reminded that they are responsible for communicating on behalf of their club and sharing all information to and from the NJYHL.

Executive Vice President Report

Gene Ross is the newly appointed Executive Vice President. No report at this time.

Administrative Vice President Report

- Midget AA playoff schedules are set and posted on the website.
- 16AA and 18AA 8 team double elimination format. This format will be updated next year. It will be limited to top 25% of the teams in the division.
- Squirt scorekeeper passwords were sent out yesterday. The squirt teams can now enter games into the system. No fines for late entries will be assessed for this past weekend.
- Scorekeeper fines are very high this year scores being entered have many mistakes.
 Please train your scorekeepers to input the information correctly. Corrections bring fines.
- Game forfeits receive a \$1,000 fine per game. Teams cannot decide to forfeit games. Only the NJYHL can forfeit a game.
